- 2. Keeping in view of recent surge in COVID-19 cases and to make adequate funds available to the State Governments for taking containment measures, as a special dispensation, the above amount is being released to the State Governments in advance based on the recommendation received from MHA vide their O.M. No.33-05/2021-NDM-I dated 29th April,2021.
- 3. RBI may be requested to **credit** the above amount into the Account of the concerned State Governments immediately.
- Release of funds will be governed by the existing guidelines and norms of SDRF/NDRF.
- 5. The above amount will be booked under the Head 3601.07.104.01.00.31 in Grant No.40 -Transfer to States for 2021-22.
- 6. As directed by the Election Commission of India, the release of grants to the States [(i) Assam (ii) Kerala (iii) Tamil Nadu & (iv) West Bengal] where the Model code of conduct is in-force, following conditions shall be applied:
 - (i) Absolutely no publicity in this regard shall be made in electronic, print, radio, internet or any other media, in any form whatsoever.
 - (ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
 - (iii) These restrictions on publicity will be applicable to the Central Government as well as the State Government.
 - (iv) The relevant provisions of Model Code of Conduct issued by the Commission shall be strictly followed.
