

3. **The State shall adhere to para 6.4 (vii) of Chapter 6 of FC-XV Report for allocation/utilization of the Disaster Risk Management Grant. The guidelines on the utilization of fund etc. are to be finalized by the MHA/NDMA. However, in the light of the outbreak of COVID-19, MHA extended the validity of the guidelines of 14th F.C. in operation upto 31.03.2021.**
