2. Supplementary Nutrition Programme (SNP) is a DBT Scheme and States/UTs are mandated to implement SNP strictly in DBT mode w.e.f. 1<sup>st</sup> April, 2018 in terms of notification issued under the Aadhaar Act, 2016. Accordingly, States/UTs are required to take following action:

(i) Authentication of all beneficiaries using Aadhaar as primary identifier;

(ii) Follow exception handling mechanism for beneficiaries not having Aadhaar;

(iii) Ensure that no genuine beneficiary is denied of the benefits and services for not possessing Aadhaar; and

The information on expenditure on Supplementary Nutrition Programme from 1<sup>st</sup> April to 30<sup>th</sup> June must be furnished by 15<sup>th</sup> July and for the period from 1<sup>st</sup> July to 30<sup>th</sup> September by 15<sup>th</sup> October and from the period 1<sup>st</sup> October to 31<sup>st</sup> December by 15<sup>th</sup> January and from 1<sup>st</sup> January to 31<sup>st</sup> March by 15<sup>th</sup> April to enable the Ministry to work out the entitlement of Central assistance of the State Government/UT Administration.

9. The pattern of grants-in aid has already been approved by the Ministry of Finance. This Sanction is being issued in conformity with the rules and principles of the scheme approved by the Ministry of Finance.
