The amount of above loan is the enhanced additional allocation of loan under Part-I of the 'Scheme for Special Assistance to States for Capital Expenditure for 2021-22' and is being released based on the guidelines of the Scheme issued by the Department of Expenditure vide letter No. 44(1)/PF-S/2021-22 (CAPEX) dated 29.04.2021, request received from Finance Department, Government of Himachal Pradesh for the amount released in 2021-22 vide D.O. letter No. PLG(PI)1-42/2021(Misc. Corr.) dated 29.03.2022, subject to the following conditions:
 - i. The amount released by the Union Government shall be released to the Implementing Agencies of the State Government within 10 working days.
 - ii. The amount released shall be utilized by 31.03.2022.
- iii. The State Government shall ensure that there is no duplication in funding of the projects approved under the scheme either with the funds provided by the Government of India or the State Government.
- iv. In case of unavoidable changes in the specific project for which funds are being released, the State Government shall seek the approval of the Government of India for the change. Funds will not be provided in case of un-approved changes.
- v. Expenditure by the State of the funds provided under the Scheme, for purposes other than for which the funds were sanctioned, will result in the deduction of the amounts by the Government of India from the devolution of the taxes to the State.
- vi. All provisions of the guidelines of the Scheme issued vide letter No. 44(1)/PF-S/2021-22 (CAPEX) dated 29.04.2021 shall be applicable in toto and shall be strictly adhered to by the State Government of Himachal Pradesh and its implementing agencies.
