Subject:- Release of advance first installment of central share for implementation of the Centrally Sponsored Scheme (CSS) – "Scheme for Modernization and Reforms through Technology in Public Distribution System (SMART-PDS)" during the year 2024-25 to State Government of Himachal Pradesh –reg.

Sir,

I am directed to refer to this Department's Administrative Approval issued vide letter No.4(1)/2020/Comp.Cell dated 04.05.2023 for **implementation of the Centrally Sponsored Scheme (CSS)** – "Scheme for Modernization and Reforms through Technology in Public Distribution System (SMART-PDS)" in all State/UT during the period of 3 years (April 2023 to March 2026). In this regard, proposal dated 01.05.2024 received from State Government of Himachal Pradesh seeking financial assistance for advance of first installment for the implementation of the scheme has been examined by this Department.

- 2. Further, As per Administrative Approval dated 04.05.2023, the funds would be released to F&CS Department of the States/UTs in twelve installments (each installment of 25% of one year cost) subject to fulfillment of conditions mentioned therein. For releasing the financial assistance of first installment following conditions are to be met:
  - i. Submission of State specific proposal as per template provided by DoF&PD.
  - ii. Signed of MoU between State/UT and DoF&PD.
- 3. The total admissible cost under SMART-PDS Scheme for the State Government of Himachal Pradesh is Rs.1,03,41,048/- for one year, out of which Government of India's share is 90% i.e. Rs.93,06,943/-. State Government of Himachal Pradesh fulfills the conditions mentioned in above para 2 for release of first installment of central share @ 25% i.e. Rs.23,26,700/- (rounded off) under SMART-PDS Scheme. Accordingly, in compliance, I am directed to convey the sanction of President of India for payment of Rs. 23,26,700/- (Rupees Twenty-Three Lakh Twenty-Six Thousand and Seven Hundred Only) as advance first installment to the State Government of Himachal Pradesh for implementation of Centrally Sponsored Scheme (CSS) "Scheme for Modernization and Reforms through Technology in Public Distribution System (SMART-PDS)" during the current FY 2024-25 as per Annex-1.
- 4. The above sanction is subject to the following conditions:
  - i. All terms and conditions stipulated in the MoU shall be observed strictly by the State/UT Government.
  - ii. The sanctioned amount shall be spent for the purpose for which it is being sanctioned. Utilization Certificate in the prescribed proforma (Annex-II) would be furnished by the State/UT Government immediately on utilization of the sanctioned amount.

1 Sugar

The 2<sup>nd</sup> instalment of 25% would be released only after receipt of the UC, duly authenticated iii. in prescribed proforma. The utilization of funds also to be uploaded on PFMS portal.

Any part of the sanctioned amount which is not utilized shall be refunded to the Central iv. Government immediately, along with the Utilization Certificate in the prescribed proforma in

respect of amount spent.

In case of non-utilization of the sanctioned amount, the State/UT Government shall also pay ٧. penal interest thereon as per provisions contained in the General Financial Rules, Government of India.

Strict compliance of all the conditions mentioned in Election Commission of India's letter dated vi.

23.03.2024 (copy enclosed).
