- 2. Payments may kindly be made to the State Government immediately.
- 3. The amount of above loan is the loan during 2022-23 under Part-IV of the 'Scheme for Special Assistance to States for Capital Investment for 2022-23' towards capital projects communicated vide Department of Expenditure letter No. 44(1)/PF-S/(CAPEX)-Part-IV/2022-23 dated 08.02.2023 to the State Government of Himachal Pradesh and Ministry of Electronics & Information Technology (MeitY) and is being released based on the guidelines of the Scheme issued by the Department of Expenditure vide letters No. 44(1)/PF-S/2022-23 (CAPEX) dated 06.04.2022, 06.07.2022 and 16.12.2022, recommendations received from the MeitY vide O.M. No. 12(5)/2022-EG-II dated 01.11.2022 and request received from the State Government of Himachal Pradesh vide Letter No. PLG (PI) 1-42/2022 dated 20.01.2023 subject to the following conditions:
  - Violations in respect of eligibility of conditions/reforms as detailed in Para (3)(iv) of the Scheme guidelines issued vide letters No. 44(1)/PF-S/2022-23 (CAPEX) dated 06.04.2022 will result in the deduction of amounts by the Government of India from devolution of taxes to the State.

The States shall submit Utilization Certificate (UC) against the released funds to MeitY and the UC shall be supported by project specific utilization as on 31.03.2023 approved under the Part-IV of the Scheme by DoE.

- iii. MeitY shall examine the UC and supporting details as per the approved capital expenditure on the projects conveyed to the States and MeitY and submit the Utilization Certificate (UC) as on 31.03.2023, which shall be further forwarded to DoE.
- iv. The amount released by the Union Government shall be released to the Implementing Agencies of the State Government within 10 working days.
- v. The amount released shall be utilized by 31.03.2023.
- vi. The State Government shall ensure that there is no duplication in funding of the capital projects approved under the Scheme either with the funds provided by the Government of India or the State Government.
- vii. In case of unavoidable changes in the specific project for which funds are being released, the State Government shall seek the approval of the Government of India for the change. Funds will not be provided in case of un-approved changes.



- Expenditure by the State of the funds provided under the Scheme, for purposes other than for which the funds were sanctioned, will result in the deduction of the amounts by the Government of India from the devolution of the taxes to the State.
- All provisions of the guidelines of the Scheme issued vide letters no. 44(1)/PF-S/2022-23 ix. (CAPEX) dated 06.04.2022, 06.07.2022 and 16.12.2022 shall be applicable in toto and shall be strictly adhered to by the State Government of Himachal Pradesh and its implementing agencies.
- Violations of mandatory conditions detailed in Para (4) of the Scheme guidelines issued vide letter No. 44(1)/PF-S/2022-23 (CAPEX) dated 06.04.2022 will result in the deduction of amounts by the Government of India from devolution of taxes to the State.
