With reference to Government of Himachal Pradesh, Directorate of Agriculture letter No.Agri.H(II)F(7)2/2014-II, dated 11th June, 2019, I am directed to convey the sanction of the President of India for release of **Rs.86,59,000/- (Rupees Eighty Six Lakh and Fifty Nine Thousand only)** in favour of Government of Himachal Pradesh during Rabi season of 2019-20 (exclusively for SC Farmers) for implementation of Seed Village Programme under "Sub-Mission on Seed and Planting Material (SMSP)" for the financial year 2019-20.

- The above release of fund is subject to following terms and conditions:
- a. The fund will be utilized only for the purpose it is released (i.e. exclusively for SC Farmers) and no diversion of fund will be allowed in any case.
- b. The Grantee Institutions or Organizations will submit quarterly Physical and Financial Progress Report etc. within the stipulated time or as required by Government of India.
- c. The Grantee Institutions or Organizations will submit Utilization Certificate in prescribed format as per (GFR-12C) on PFMS only [Rule 86(6)].
- d. The above release of fund is subject to terms and conditions and Guidelines set forth by this Department.
- 3. The expenditure involved is debitable to Demand No.1-Agriculture, Major Head 3601-Grants-in-Aid to State Governments, 06—Centrally Sponsored Scheme (Sub-Major Head), 789-Special Component Plan for Schedule Caste, 39-Green Revolution-Krishonnati Yojana, 01-Sub-Mission on Seeds & Planting Material, 390131-Grants-in-aid General.
- 4. The Finance Department of the State Government is requested to release the funds to Department of Agriculture, Government of Himachal Pradesh within 15 days of the release of funds by the Government of India.

- The payment sanctioned above is provisional and is subject to adjustment on the basis of the audited figures of expenditure in terms of Ministry of Finance letter No.2(19)-P.II/60, dated 09.10.1964.
- The Further use of Grants in Aid being released by this sanction order, is to be done through EAT module of PFMS. The Utilization Certificate not supported by the EAT module data is likely to be rejected and expenditure is not to be treated as regular. The agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this sanction.
- Rule 236(1)-Audit of Accounts. The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid.
- This Sanction has been noted at Sl.No.4, Page No.85 of the Control Register of Grants for 2019-20 as per requirement of GFR 2017.
