Subject: Sanction of financial assistance to Government of Himachal Pradesh for implementation of Seed Village Program under "Sub-Mission on Seed and Planting Material (SMSP)" during 2020-21.

Sir,

With reference to Government of Himachal Pradesh, Directorate of Agriculture letter No.Agri.H(II)F(7)2/2014-II, dated 11<sup>th</sup> June, 2019, I am directed to convey the sanction of the President for release of **Rs.2,45,38,000/- (Rupees Two Crore Forty Five Lakh and Thirty Eight Thousand only)** in favour of Government of Himachal Pradesh for General Farmers for implementation of Seed Village Program during Rabi season of 2020-21 under "Sub-Mission on Seed and Planting Material (SMSP)" for the financial year 2020-21.

2. The above release of fund is subject to following terms and conditions:
  - a. The fund will be utilized only for the purpose it is released and no diversion of fund will be allowed in any case.
  - b. The Grantee Institutions or Organizations will submit quarterly Physical and Financial Progress Report etc. within the stipulated time or as required by Government of India.
  - c. The Grantee Institutions or Organizations will submit Utilization Certificate in prescribed format as per (GFR-12C) on PFMS only [Rule 86(6)].
  - d. The above release of fund is subject to terms and conditions and Guidelines set forth by this Department.
3. The expenditure involved is debit to Demand No.1-Agriculture, Major Head 3601-Grant-in-aid to State Government, 06-Centrally Sponsored Scheme, 101-central Assistance/Share, 43-Green Revolution-Krishonnati Yojana, 01-Sub-Mission on Seeds and Planting Material, 430131- Grants-in-aid General.
4. The Finance Department of the State Government is requested to release the funds to Department of Agriculture, Government of Himachal Pradesh within 15 days of the release of funds by the Government of India.
5. Necessary Utilization Certificate has been uploaded in the PFMS and copy is enclosed for ready reference.

7. Further use of Grants in Aid being released by this sanction order, is to be done through EAT module of PFMS. The Utilization Certificate not supported by the EAT module data is likely to be rejected and expenditure is not to be treated as regular. The agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this sanction.
8. Rule 236(1)-Audit of Accounts. The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid.
9. This Sanction has been noted at Sl.No. 7, Page No. 71 of the Control Register of Grants for 2020-21 as per requirement of GFR 2017.
10. The sanction issues with the concurrence of the Integrated Finance Division of this Department vide Dy.No.88939-FTS/SS&FA, dated 01.10.2020.
