With reference to Director of Agriculture, Govt. of Himachal Pradesh letter No. Agr.H(II-Tech)F(7)2/2014-V dated 13.12.2022, I am directed to convey the sanction of the Competent Authority for release of Rs.4,01,05,800/- (Rupees Four Crore One Lakh Five Thousand Eight Hundred only) as second installment in favour of Government of Himachal Pradesh for General Farmers for implementation of Seed Village Program under 'Seeds and Planting Material (erstwhile SMSP)' for the financial year 2022-23.

- 2. The above release of fund is subject to following terms and conditions:
  - a. The fund will be utilized only for the purpose it is released and no diversion of fund will be allowed in any case.
  - b. The Grantee Institutions or Organizations will submit quarterly Physical and Financial Progress Report etc. within the stipulated time or as required by Government of India.
  - c. The Grantee Institutions or Organizations will submit Utilization Certificate in prescribed format as per (GFR-12C) on PFMS only [Rule 86(6)].
  - d. The above release of fund is subject to terms and conditions and Guidelines set forth by this Department.
- 3. The expenditure involved is debitable to Demand No.1-Agriculture, Major Head 3601 Grants-in-Aid to State Governments, 06 Centrally Sponsored Scheme (Sub-Major Head), 101 Central Assistance/Share (Minor Head), 95 Krishonnati Yojana, 01 Seeds and Planting Material, 950131 Grants-in-aid General.
- 4. The Finance Department of the State Government is requested to release the funds to Department of Agriculture, Government of Himachal Pradesh within 15 days of the release of funds by the Government of India.
- 5. Necessary Utilization Certificate has been uploaded in the PFMS.
- 6. The nature of grants is recurring.
- 7. The payment sanctioned above is provisional and is subject to adjustment on the basis of the audited figures of expenditure in terms of Ministry of Finance letter No.2(19)-P.II/60, dated 09.10.1964.

The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid.
- 10. This Sanction has been noted at Sl.No. 02, Page No. 86 of the Control Register of Grants for 2022-23 as per requirement of GFR 2017.
