  - c) The State Government will submit Utilization Certificate in prescribed proforma (GFR-12C) on PFMS only [Rule 86(6)].
  - d) The above release of funds is subject to terms and conditions and Guidelines set forth by this Department.
  - e) The Authority should undertake not to encumber, dispose of/or otherwise utilize the assets created wholly or mainly from out of the funds except with the prior permission of the Government of India.

The expenditure involved is debitable to Demand No.1-Agriculture, Major Head 3601 Grants-in-Aid to State Governments, 06 Centrally Sponsored Scheme (Sub-Major Head), 101 Central Assistance/Share (Minor Head), 43 Green Revolution Krishonnati Yojana, 01 Submission on Seeds and Planting Material, 430135 Grants for creation of Capital Assets.
- 4. The Finance Department of the State Government is requested to release the funds to Department of Agriculture, Government of Himachal Pradesh within 15 days of the release of funds by the Government of India.
