Tech (Seed) F (7) 2/2004-I Seed Bank-13505, dated 23rd January 2018 I am directed to convey the sanction of the President of India to the release of Grants-in-aid amounting to **Rs.63,000/- (Rupees Sixty Three Thousand only)** in favour of Government of Himachal Pradesh, Shimla for reimbursement of maintenance cost including cost of services outsourced for fumigation, etc. under "National Seed Reserve" component of "Sub-Mission on Seed and Planting Material (SMSP)" during Kharif and Rabi 2018-19.

- 2. The above release of fund is subject to following terms and conditions:
 - a. The fund will only be utilized for the purpose it has been released and no diversion of fund will be allowed in any case.
 - b. The Implementing Agency will submit quarterly Physical and Financial Progress Report etc. within the stipulated time or as required by Government of India.
 - c. The State Government/Implementing Agency will submit Utilization Certificate in prescribed format as per (GFR-12C) /(GFR-12A) on PFMS only [Rule 86(6)].
 - d. The above release of fund is subject to terms and conditions and Guidelines set forth by this Department.
- 3. The expenditure involved is debitable to Demand No.1-Agriculture, Major Head 3601-Grant-in-aid to State Government, 06-Centrally Sponsored Scheme, 101-central Assistance/Share, 43-Green Revolution-Krishonnati Yojana, 01-Sub-Mission on Seeds and Planting Material, 430131—Grants-in-aid General
- 4. The payment may please be made through RTGS in favour of Government of Himachal Pradesh, Shimla and the details of Bank Account Number etc. is enclosed.
- 5. Since the release of funds is for the reimbursement of expenditure already incurred on account of maintenance of seed, Utilization Certificate is not necessary for this component.
- 6. The payment sanctioned above is provisional and is subject to adjustment on the basis of the audited figures of expenditure in terms of Ministry of Finance letter No.2(19)-P.II/60 dated 09.10.1964.

- Rule 236(1)-Audit of Accounts. The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid.
