Condition for release of funds:

1. State/ UT is to release funds to Clusters on fulfillment of the fund release conditions stipulated in the checklist circulated by Ministry to State/UT on date 14.08.2020 & revised checklist on date 07.10.2020.
2. Ministry will release the funds to State/UT on submission of 75% utilization and corresponding State Share transfer in the account of State Nodal Agency along with the conditions stipulated in the circular on fund pooling mechanism of Ministry dated 19.01.2021 & 12.01.2021.
3. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 236 (1) and 236 (2) of the General Financial Rule 2017.

8. The State Government must transfer the funds to the concerned SNA's account within a period of 21 days of its receipt. In case of non-transfer within the stipulated 21 days, Central Government may be constrained to stop further releases.
