 - 5. Expenditure by the State of the funds provided under the scheme, for purposes other than for which the funds were sanctioned, will result in the deduction of the amounts by the Government of India from the devolution of the taxes to the State.
 - 6. All provisions of the guidelines of the scheme issued vide O.M. No.44 (1)/PF-S/2020-21 dated 12.10.2020 shall be applicable in toto and shall be strictly adhered to by the State Government and implementing agencies.
