I am directed to convey the sanction of the President for release of **Rs.1,92,00,000/- (Rupees One Crore Ninety Two Lakhs only)** to the Government of Himachal Pradesh (Department of Social Justice and Empowerment) towards Grants-in-Aid under the Centrally Sponsored Scheme of Assistance to State Scheduled Castes Development Corporations (SCDCs) as Central Equity Share during the year 2017-18.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by NITI Aayog (Erstwhile Planning Commission) vide their circular No.M.12043/7/78-CDN, dated 27.9.1979.


3. The unspent amount, if any, may be surrendered to the Central Government in accordance with the instructions contained in Government of India, Ministry of Finance, Department of Expenditure, O.M.No.C-26035/1/77-MF, C.G.A. dated 4th June, 1977.

4. A Certificate stating that the scheme has been accepted by the State Finance Department for implementation during the current financial year as laid down in para 9 of the NITI Aayog (Erstwhile Planning Commission) letter No.PC(P)/2/62, dated 20.10.1961 relating to procedure and pattern of Central Assistance will have to be furnished to this Ministry, by the State Government.

5. In view of the importance attached to the Centrally Sponsored Scheme, it is emphasized that the State Government should not divert any part of the funds provided for this scheme, without the prior concurrence of the Government of India.

6. The above sanctioned amount is debitible to the Major Head 3601-Grants-in-aid to State Govts Sub Major Head-06(Grants for State Plan Schemes) Minor Head-789 (Special Component Plan for Scheduled Castes) Sub-Head-07(Scheme for Development of Scheduled Castes, State Scheduled Castes Development Corporation-34.08 Grants-in-Aid General-34.08.31 under Demand No.89 of the Ministry of Social Justice and Empowerment for the year 2017-18 (Plan).

7. ***"The Accounts relating to this Grant will be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry/Department, whenever the Institution/Organizations/State Govt. is called upon to do so."***




