- The expenditure is debitable to Major Head **3601**-(Grants-in-Aid to State Govts.)-**06**-(Centrally Sponsored Schemes)-**101**-(Central Assistance/Share)-**22**-(Swachh Bharat Mission)-**03**-Project Fund-**35**-Grants for creation of Capital Assets under **Demand No. 56** for the year **2018-19** of the Ministry of Housing and Urban Affairs.
- The amount will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22.02.1977.
- In addition to the entire Scheme being governed by the Guidelines of the Swachh Bharat Mission (SBM) which is available at www.swachhbharaturban.in and following the same while releasing funds to the beneficiaries/ULBs, the release of funds for the **Individual Household Toilets** and **Community/Public Toilets** will be restricted to and governed by the guidelines given in **relevant paragraphs** of the SBM guidelines.
- Entry has been made at **Sl. No. 82** of Grant-in-aid Register for the year 2018-19.
- No U.C. is pending for this project from Govt. of Himachal Pradesh.
- This issues with the approval of Finance Division vide note on **e-file No. 3107431** dated **05/11/2018**.


