Subject: Release of 2nd instalment under Capacity Building & Administrative & Office Expenses (CB&A&OE) component of Swachh Bharat Mission-Urban to Govt. of Himachal Pradesh during F.Y. 2021-22.

Sir,

I am directed to convey the sanction of competent authority for release of **Rs.45,00,000/- (Rupees Forty Five Lakh Only)** towards 2nd installment under CB&A&OE component of Swachh Bharat Mission (Urban) of the Ministry of Housing and Urban Affairs to Govt. of Himachal Pradesh during F.Y. 2021-22.

2. This sanction is issued subject to the following conditions :

- i. The amount released hereunder is for meeting the likely expenditure in the next two quarters.
- ii. The physical deliverables against targets envisaged in the Outcome Budget of the Division as applicable to the ULBs are met.
- iii. The State Government should transfer this amount of Central Assistance as well as the State's matching share to the ULBs within a period of 21 days and 40 days respectively, in view of the scheme guidelines and D/o Expenditure's instructions dated 23.03.2021. The State Share fund released and its utilisation may be apprised to this Ministry.
- iv. The State should also ensure that the instructions contained in PFMS Division, Department of Expenditure, Ministry of Finance Guidelines issued on 23.03.2021 along with subsequent instructions relating to deposit of interest etc. also needs to be ensured. These instructions were also conveyed vide this office letter No.1/18/2015-SBM dated 31.08.21.
- v. The State Govt should furnish all the pending and due UCs expeditiously.

3. The sanction will be regulated in accordance with the provisions of GFR, 2017.

4. The expenditure is debit to Major Head **3601**-(Grants-in-Aid to State Govts.)-**06**-(Centrally Sponsored Schemes)-**101**-(Central Assistance/Share)-**22**-(Swachh Bharat Mission)-**02**-Capacity Building for Swachh Bharat Mission-**31**-Grant-in-Aid General under **Demand No. 59** for the year **2021-22** of the Ministry of Housing and Urban Affairs.

5. The amount will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22.02.1977.

6. In addition to the entire Scheme being governed by the Guidelines of the Swachh Bharat Mission (SBM) which is available at www.swachhbharaturban.in and following the same while releasing funds to the beneficiaries/ULBs, the release of funds **for CB&A&OE component** will be restricted to and governed by the guidelines given in relevant **paragraph** of the SBM guidelines.
