Sub: Release of funds to various State Governments as Mobilization Advance for Solid Waste Management projects and Used Water Management projects under Swachh Bharat Mission 2.0 during 2021-22 - reg

Sir,

I am directed to convey the sanction of the Competent Authority for release of a Mobilization Advance amounting to **Rs.1,29,00,00,000/- (Rupees One Hundred and Twenty Nine Crores only) @ Rs.4,00,000/- (Rupees Four Lakhs only) per ULB (Rs.2,00,000/- for Solid Waste Management and Rs.2,00,000/- for Used Water Management)**, to each of the states as detailed in the table below, under Swachh Bharat Mission 2.0 (Urban) of the Ministry of Housing and Urban Affairs for Financial Year **2021-22**. The release is subject to the condition that the same will be adjusted against release of first installment of Central Share of funds against these components.

2. This sanction is subject to the following conditions:

- (a) The State Government must transfer this amount of Central Assistance as well as the State's matching share to the ULBs within a period of 21 days and 40 days respectively, and that the state share funds released and its utilization may be apprised to this Ministry.
- (b) The State should also ensure that the instructions in PFMS Division, Department of Expenditure, Ministry of Finance Guidelines issued on 23.03.2021, along with subsequent instructions relating to deposit of interest etc. also need to be complied with. These instructions were also conveyed vide this office letter No. 1/18/2015-SBM dated 31.08.2021.

3. The sanction will be regulated in accordance with the provisions of GFR, 2017.
4. The expenditure is debitible to Major Head **3601** – (Grants-in-Aid to State Govts) – **06** – (Centrally Sponsored Schemes) – **101** – (Central Assistance/Share) – **22** – (Swachh Bharat Mission) – **03** – Project Fund – 35 – grants for creation of Capital assets under Demand No. **59** for the year **2021-22** of the Ministry of Housing and Urban Affairs.
5. The amount will be credited to the State Government's account in RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II(45/76/SC) dated 22.02.1977.
6. In addition to the entire Scheme being governed by the Guidelines of the Swachh Bharat Mission (SBM) which is available at [www.mohua.gov.in](http://www.mohua.gov.in) and following the same while releasing funds to beneficiaries/ULBs, the release of funds for the Solid Waste Management and Used Water Management component will be restricted to and governed by the relevant paras of the Operational guidelines of SBM (U) 2.0.
7. Entry has been made at Sl. No. **19** in the Grant-in-Aids Register for the year **2021-22**.
