4. The amount will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No. F-II (45/76/SC) dated 22.02.1977.
5. In addition to the entire Scheme being governed by the Guidelines of the Swachh Bharat Mission (SBM) which is available at www.moud.gov.in and following the same while releasing funds to the beneficiaries/ULBs, the release of funds for the Capacity Building and A&OE Component will be restricted to and governed by the guidelines given in paragraph 9 of the SBM guidelines.
6. Entry has been made at Sl. No. **96** of Grant-in-aid Register for the year 2016-17.
7. No U.C. is pending for this project from Govt. of Himachal Pradesh.
