I am directed to convey the approval of Government of India for release of Rs. 180340.97 Lakh (Rupees One Thousand Eight Hundred Three Crore, Forty Lakh and Ninety-Seven Thousand Only) as Performance Grants for Urban Local bodies for the following State Government(s) and as per details given below, during 2016-2017 as per the recommendations of the Fourteenth Finance Commission:-

2. The State Government(s) are advised to ensure that grants are distributed as per the approved & notified scheme for disbursement of Performance Grant. However, in case any undistributed fund remains, it should be distributed to all the eligible Urban Local bodies(ULBs) as per the formula recommended in the latest State Finance Commission Report(SFC). However, in the absence of SFC formula, Grant should be distributed using population of 2011 Census with a weight of 90% and Area with a weight of 10%.

3. State(s) need to transfer above amount(s) to local bodies within fifteen days of receipt from Central Government. Any delay will require the State Government(s) to release the instalment with interest, at bank rate of RBI, for number of days of delay.


