OFFICE MEMORANDUM

Subject:- Regarding Leave Travel Concession for All India Services Officers.

The undersigned is directed to invite a reference to this Department Office Memorandum No. Fin(C)A(3)-11/98 dated 1st June, 2006.

While dealing with the issue of Leave Travel Concession, it was brought to the notice of the Government that the said Office Memorandum does not conform to Rule 3(2) of the All India Services (Leave Travel Concession) Rules, 1975. The proviso under Rule 3(2) is as under:-


"Provided that the concession afforded to a member of the Service under this sub-rule shall not at any time be inferior to that to which he would be entitled under sub-rule(1), had he been appointed to serve in connection with the affairs of the Union."

After re-consideration, it has been decided that the Leave Travel Concession to the officers of All India Services will be governed by the Rules, *ibid*.
