In exercise of the powers vested under sub-section (4) 12 read with sub-section (1) of section 20 of the Pension Fund Regulatory and Development Authority Act, 2013 (Act no. 23 of 2013), the Governor of Himachal Pradesh is pleased to order that the Contributory Pension Scheme (also called New Pension System) made applicable to all Government employees appointed on or after 15th May, 2003 vide Notification No. Fin(Pen)A(3)-1/96 dated 17th August, 2006 under the provision of the H.P. Civil Service Contributory Pension Rules 2006 read with Notification No. Fin(Pen)A(3)-1/96 dated 15.05.2003 shall be deemed to be National Pension System from the 15th May,2003.
