2. You are requested to advise the Reserve Bank of India, Nagpur to credit the above amount to the accounts of the respective State Government(s) immediately.

The payments are adjustable in the accounts of the Ministry of Finance in **Demand Grant No. 038 - Transfers to State and Union Territory Government(s)** for the year **2019-20** under Function Head **3601071020100**, Object Head 31, Scheme code **2084** as Grants-in-aid to States for Local Bodies Grants.
4. The State Government(s) is/are advised to ensure that grants are distributed as per the approved formula recommended in the latest State Finance Commission Report (SFC). However, in the absence of SFC formula, Grant should be distributed using population of 2011 Census with a weight of 90% and Area with a weight of 10%.
5. The State(s) need to transfer above amount(s) to Local Bodies **within fifteen days** of receipt from Central Government. Any delay will require the State Government(s) to release the instalment with interest, at bank rate of RBI, for number of days of delay.
6. Distribution and Utilization should be in consonance with the Local body Guidelines issued vide letter No. 13 (32)FFC/ FCD/2015-16, dated 8th October, 2015.
7. The action taken on this letter may be intimated to this Division.
