2. The above appointment is, however, subject to the following conditions:-

- (i) As and when incumbent of Ex-Cadre post of Superintendent Grade-II is promoted as Superintendent Grade-II in regular line of promotion or these posts are abolished, the post held in abeyance would stand revived.
- (ii) The official appointed against the above Ex-cadre post of Superintendent Grade-II would continue to perform their present duties according to the existing system.
- (iii) The appointment of all these officials would, however, be subject to the condition that services rendered by him/her against Ex-cadre post of Superintendent Grade-II, would not be counted for experience as Superintendent Grade-II, for promotion to higher post in the regular line.
- (iv) The provisions of FR-22(1)(a)(i) will not be attracted in the case of above appointment.
- (v) Only those Senior Assistants who have rendered 17 years combined service as Clerk/Junior Assistants/Sr.Assistants in the H.P.Secretariat are designated as Ex-Cadre Superintendents.

3. In case the above terms and conditions are acceptable to the above officials, they may submit their joining reports to this department within a period of fortnight failing which the above appointment/re-designation shall be deemed as cancelled.


