

**OFFICE ORDER**

2. The payment of allowances, entitlements etc. will be governed as per the Finance Department's clarification issued vide letter No. Fin(C)B(7)-1/2021 dated 3<sup>rd</sup> January, 2022. Dearness allowance will be admissible on the rates mentioned in FD's OM No. Fin(C) B(7)-1/2021 dated 3<sup>rd</sup> January, 2022 and 9<sup>th</sup> February, 2022.
3. The payment of arrear on account of this fixation shall be made to the concerned employee as per the provisions contained under Rule-13 of the H.P. Civil Services (Revised Pay) Rules, 2022.
4. This pay fixation is subject to audit verification and overpayments if any, detected later on, the same shall be recovered from the concerned official in lumpsum.


