**OFFICE ORDER**

Consequent upon the revision of pay scales of H.P. Government Employees w.e.f. 01.01.2016 vide Notification No. Fin-(PR)B(7)-1/2021 dated 3<sup>rd</sup> January, 2022, the pay of Sh. 


