OFFICE ORDER

Consequent upon the revision of pay scales of H.P. Government Employees w.e.f. 01.01.2016 vide Notification No. Fin-(PR)B(7)-1/2021 dated 3rd January, 2022, the pay of Sh. Prem Singh Raghuvanshi who was appointed as Senior Private Secretary (Co-terminus) on Secondment basis at the then HP Chief Minister's, Camp Office New Delhi, is hereby fixed in revised pay structure as per statement attached in **Annexure "A"**.


