

OFFICE ORDER

Consequent upon the revision of pay scales of H.P. Government Employees w.e.f. 01.01.2016 vide Notification No. Fin-(PR)B(7)-1/2021 dated 3rd January, 2022, the pay of Sh. 2. The payment of allowances, entitlements etc. will be governed as per the Finance Department's clarification issued vide letter No. Fin(C)B(7)-1/2021 dated 3rd January, 2022. Dearness allowance will be admissible on the rates mentioned in FD's OM No. Fin(C) B(7)-1/2021 dated 3rd January, 2022 and 9th February, 2022.
3. The payment of arrear on account of this fixation shall be made to the concerned employee as per the provisions contained under Rule-13 of the H.P. Civil Services (Revised Pay) Rules, 2022.
4. This pay fixation is subject to audit verification and overpayments if any, detected later on, the same shall be recovered from the concerned official in lumpsum.




