

OFFICE ORDER

Consequent upon the revision of pay scales of H.P. Government Employees w.e.f. 01.01.2016 vide Notification No. Fin-(PR)B(7)-1/2021 dated 3rd January, 2022 and as per FD letter No. FIN (PR)-B(7)-1/2021-LOOSE dated 10th February, 2022, the pay of 10 Senior Assistants is hereby fixed on the basis of their options, as per statement attached.

Dearness allowance will be admissible on the rates mentioned in FD's OM No. Fin(C) B(7)-1/2021 dated 3rd January, 2022 and 9th February, 2022.
3. The payment of arrear on account of this fixation and other conditions will be governed as per the instructions of Finance Department issued vide letter No. FIN (PR)-B(7)-1/2021-LOOSE dated 10th February, 2022.
4. This pay fixation is subject to audit verification and the overpayments if any, detected later on, the same shall be recovered from the concerned official(s) in lumpsum.


