

OFFICE ORDER


Consequent upon the revision of pay scales of H.P. Government Employees w.e.f. 01.01.2016 vide Notification No. Fin-(PR)B(7)-1/2021 dated 3rd January, 2022, the pay of 05 Clerks is hereby fixed in Level-3 of the Schedule as per statement attached.

2. The payment of allowances, entitlements etc. will be governed as per the Finance Department's clarification issued vide letter No. Fin(C)B(7)-1/2021 dated 3rd January, 2022. Dearness allowance will be admissible on the rates mentioned in FD's OM Nos. Fin(C) B(7)-1/2021 dated 3rd January, 2022 and 9th February, 2022.


