**OFFICE ORDER**

1. A certificate of fitness from the Chief Medical Officer, DDU Hospital, Shimla has to be produced at the time of joining. For this purpose he/ she is required to bring two pass post size photographs with them.
  2. He/ she will have to enroll as a member of the H.P. Employees Group Insurance Scheme, if not already enrolled.
  3. The other conditions of service including pay fixation etc. will be governed by the relevant Rules and orders/ instructions in force and issued from time to time.

4. This offer of appointment shall be subject to the verification of character and antecedents of the candidates. If anything adverse is reported against the candidates, this appointment will be treated as null and void.
5. He/ she will remain on probation for a period of two years subject to such further extension ordered by the Competent Authority. Further, in case the work and conduct of the official is not found satisfactory, the appointment as Clerk will be withdrawn.
6. His/ her regularization shall be at the minimum of the time scale of the post.
7. This regularization will be with prospective effect i.e. from the date of issue of regularization orders.

If the order of appointment on the above terms & conditions is acceptable to him/ her, he/ she may join duties within the period of one week after completing all the codal formalities failing which the offer shall stand cancelled.


