Requisition to fill up 08 posts has already been sent to HP,SSC Hamirpur & process to fill up the remaining 03 posts is underway. It is pointed out that these 08 posts could not be filled up by the commission even after number of attempts. The SAD should take up the matter with the Commission and wherever any de-reservation/relaxation is required, the same be obtained. (SAD)

ITEM NO:02 AMENDEMENT IN THE R&P RULES OF JR.SCALE STENOGRAPHERS

The demand of the Association to do away the provision of contractual appointment was not acceded to, as the appointment on contractual basis at initial level is as per the policy of the Government. (DOP)

ITEM NO. 03 AMENDMENT IN THE R&P RULES OF SR.SCALE STENOGRAPHERS

The demand of the Association to remove the qualification of Graduation in case of promotion to the post of Sr. Scale Stenographers was discussed thoroughly and it was intimated by the ACS (Personnel) that this issue is coming up in other categories also. Hence, it was decided to examine this demand on departmental file. As regards the demand of the Association to abolish the "failing clause" i.e. by Direct Recruitment on a regular basis or on contract basis, it was observed that the
