MEMORANDUM

**Subject:** Revised final seniority list of Junior Scale Stenographers of H.P. Secretariat as stood on 31.10.2024 in compliance of the judgement dated 03.08.2023 passed by Hon'ble High Court in CWP titled as Taj Mohammad Vs State of H.P.

In compliance of the judgement dated 03.08.2023 passed by Hon'ble High Court in CWP No. 2004 of 2017- titled as Taj Mohammad & Others Vs State of H.P. & Ors., the tentative seniority list of Junior Scale Stenographer indicating the position as on 31.10.2024 was circulated vide this Department's Memorandum of even number dated 04.11.2024. Representations/objections have been received from some officials namely Smt. Asha Prashar, SSS, Smt. Kiran Gupta, SSS, Sh. Rattan Singh, SSS, Sh. Raj Kumar, SSS, Smt. Tripta Dogra, SSS, Smt. Pawna Jaswa, SSS and Smt. Promila Rao, SSS against the tentative seniority list. The objections raised by the officials have carefully been considered and it has been found that the seniority position of all the officials in the revised tentative seniority list has been assigned in compliance of the judgment dated 03.08.2023 passed by Hon'ble High Court in CWP No. 2004 of 2017- titled as Taj Mohammad & Others Vs State of H.P. & Ors. by counting their contractual service. Hence, the objections/claim made by these incumbents are not justified and same are hereby rejected except the request made by Sh. Sanjay Singh Parihar for correction of his DOB which has been found correct and as such correction has been carried out in the final seniority list of the Junior Scale Stenographer after doing the needful.

Accordingly, the revised final seniority list of Junior Scale Stenographer is hereby circulated as per Annexure-A for information of all the officials. No representation against this final seniority list will be entertained except clerical mistakes which will only be entertained within a period of 10 days from the date of issue of the seniority list.
