NOTIFICATION

Secretariat Administration Department placed the requisition to fill up the 06(Six) posts of Physical Handicapped in H.P. Secretariat under 3% quota and advertised vide advertisement No. DPR/HP/5507 dated 29.01.2021. Out of these 04(Four) posts are falling in the category of **Orthopedically Handicapped(OH) and Hearing Impaired(HI)**.

In response to this advertisement, 1254 applications (i.e. 180 under Hearing Impaired(HI) & 1074 under Orthopedically Handicapped(OH) category) were received wherein 1227 applications were provisionally admitted and 27 applications were found invalid. Out of admitted applications, 173 candidates have applied under Hearing Impaired (HI) category & 1054 under Orthopedically Handicapped(OH) category.

In the initial evaluation process, out of the 1227 applications from the category of OH & HI, the following 14 candidates have been provisionally shortlisted for further selection process:-
