CIRCULAR

The Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 have been notified by the Government vide Finance Department's notification No. Fin-(PR)B(7)-1/2021 dated 3rd January, 2022. Now the pay of all the regular employees will be fixed in the revised pay structure w.e.f. 1-1-2016 onwards. As per provision of Rule 6(1) of these rules, employee shall exercise option within a period of one month from the date of notification of these rules. The employee whose date of increment falls on 1-1-2016, shall have the option to draw the increment in the existing scale or in the revised pay structure as per Note 2. below Rule 7 (II) (b) (iii). Further, as per provision of Rule 8(V), a Government employee, who stand promoted between the period from 1st day of January, 2016 to the date of notification of these rules, may exercise option within a period of one month from the date of such notification alongwith the option for pay revision as per rule 6. The option(s) once exercised shall be final.

Therefore, all the officers/officials who were/are working under the control of Secretariat Administration Services-I on or after 1-1-2016 are requested to exercise their option(s) as stated above on the prescribed proforma enclosed with this circular.
