
The Technical Bid must contain the following:-

The Technical Bid shall be opened first and the financial bid on the prescribed proforma (Annexure-A) of those bidder who are technically qualified shall be opened in accordance with provisions of the H.P. financial rules, 2009 by the committee constituted for the purpose by the Government of H.P.

- 3. The rates quoted should be strictly according to the description & specifications on the prescribed proforma for Financial Bid in a separate envelop annexed as Annexure-A.
- 4. The Under Secretary (SAR&I-I) has reserves the right to accept or reject any or all tenders without assigning any reasons or to reduce, increase or remove the items.



- 5. The quality of Trolley bag shall be ensured by the vendor. If any quality issue found in the item, the vendor shall provide new Trolley Bag, If still problem persists, then tender will be liable to the cancelled and in that case new tender will be given to L-2 Firm on the approved L-I rate(s) for which L-I bidder shall not have right to raise any objection.
- 6. The Contractor shall not sublet transfer or assign the job without the written permission of the Under Secretary (SA) to the Government of Himachal Pradesh has right to terminate the contract.
- 7. Payment shall not be made in advance in any case.
- 8. The rates quoted should be inclusive of all taxes and F.O. R. destination of SAR&I-I Section, HP Secretariat.
- 9. The article should be supplied within a week time from the date of supply order.
