**NOTIFICATION**

The Governor, Himachal Pradesh is pleased to notify terms and conditions in respect of Circuit House Willy's Park Shimla in public interest with immediate effect as under:-

- (1) That the Circuit House, Willy's Park, Shimla will run on quasi commercial basis. The reservation of 49 rooms out of 89 rooms in Circuit House Willy's Park Shimla will be done by GAD and room tariff of these 49 rooms will be fixed by Government. The remaining 40 rooms and other usable space of Circuit House Willy's Park Shimla will be under the control of HPTDC and shall be run by HPTDC on commercial basis at the rates fixed by HPTDC from time to time.
- (2) That the HPTDC will deploy Managerial and other Operational Staff as per HPTDC norms and all such staff deployed on the job will be granted pay and other benefits as admissible to their counterparts in HPTDC Limited.
- (3) That all the Accounts pertaining to total 89 rooms & other space will be audited by the Auditors appointed by the Managing Director, HPTDC or Accountant General H.P. as the case may be. In case of difference between income & expenditure of Circuit House Willy's Park Shimla, the difference if surplus, will be deposited in the Government Treasury (General Receipt). In case the difference is in deficit, Government will release the funds for deficit of previous year on the basis of audited report of Competent Authority in the next financial year under relevant Head of Account of State Hospitality & Protocol Department of the State Government.
- (4) That the General Administration Department (GAD) of the State Government will be the Administrative Department in respect of Circuit House, Willy's Park, Shimla.
- (5) That the repair, addition and alteration, improvements etc of Circuit House, Willy's Park Shimla as per requirement will be carried out by HPTDC.

- (6) That the reservation of the rooms other than commercial rooms in this entity will also be controlled by the State Government in the General Administration Department.
- (7) That the Managing Director, HPTDC will have the same financial and administrative powers to run this Unit as are being exercised by him/her in respect of other HPTDC units.
- (8) That rates of rooms other than commercial rooms in these entities will be fixed/revised from time to time by General Administration Department.
- (9) That the rates of food items in respect of GAD rooms shall be fixed/revised from time to time by the General Administration Department.
- (10) That the HPTDC will maintain Circuit House Willy's Park without seeking any Grant-in-Aid or funds from the Government


