



NOTIFICATION

The Governor, Himachal Pradesh is pleased to declare **2nd May, 2023 (Tuesday)** as a **"Paid Holiday"** (in case poll is held) in the areas of Municipal Corporation Shimla where general election to be held and is Ward No. 02, Palampur Upperla of Municipal Corporation Palampur where bye election are to be held. **This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.**

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in MC Shimla and Ward No. 02 of MC Palampur, on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/ her vote.




