This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in Panchayats of above Development Blocks, H.P. (where the election are scheduled to be held) on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/her vote.
