NOTIFICATION

The Governor, Himachal Pradesh is pleased to declare 7th April, 2021 (Wednesday) as public holiday (in case poll is held) in Development Blocks Chopal and Tutu of District Shimla and Development Block Dharampur of District Mandi, Himachal Pradesh, on account of general election in the Panchayats of above Developments Blocks (in the areas of those PRIs, where the election are scheduled to be held). All Government Offices, Boards, Corporations, Educational Institutions and Industrial Establishments situated in the Himachal Pradesh under Industrial Disputes Act and shops will remain closed on the said date in the **areas of above Institutions**. This will also be a **paid holiday** to daily wages employees and also within the meaning of **Section 25 of Negotiable Instrument Act 1881**.

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in Panchayats of above Development Blocks, H.P. (where the election are scheduled to be held) **on the production of certificate** from the concerned Presiding Officer that the employee has actually cast his/ her vote.


