GAD-D-7(G)1-12/81, dated 1st June, 1994 and published in Rajpatra, Himachal Pradesh (Extra Ordinary) dated 18th July, 1994, namely:-

Short title and Commencement.

- (1) These rules may be called the Himachal Pradesh Allotment of Government Residences (General Pool) 13th Amendment Rules, 2023.
 - (2) These rules come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.

Amendment of rule 8

2.

- In rule 8 of the Himachal Pradesh Allotment of Government Residences (General Pool) Rules, 1994, in ground No. (9),-
 - (i) for clause (i), the following clause shall be substituted, namely:
 "Regular correspondents of daily newspapers

"Regular correspondents of daily newspapers published at National/Regional/State level with a minimum circulation of 60,000 copies, out of which 10,000 copies shall be in Himachal Pradesh and those of News Agencies or Electronic News channels broadcasted/ telecasted at National Level shall be eligible for allotment of Government accommodation at Shimla not above Type-IV house, provided he/she,-

(a) holds a Bachelor's degree/ Diploma in

Journalism/Mass Communication;

- (b) has minimum 10 years of experience in this field;
- (c) has State Level Accreditation accorded by the Government of Himachal Pradesh; and
- (d) does not own a house at Shimla in his/her own name or in the name of any member of his family.

Certification of Director, Information and Public Relation, Himachal Pradesh will be obtained regarding circulation/viewership.";

(ii) for the second proviso, the following shall be substituted, namely:-

"Provided further that an allottee of accommodation under clause (i) shall pay the license fee of the type of accommodation allotted to him/her as follows:-

Type-III - ₹ 2500 Per Month

Type- IV - ₹ 5000 Per Month. "; and

(iii) The proviso of Clause (iv) shall be deleted.
