**NOTIFICATION**

The Governor, Himachal Pradesh, in exercise of the powers vested in him under Rule-7 of the H.P. Police Service Rules, 1973, on the recommendations of the Departmental Promotion Committee and in consultation with H.P. Public Service Commission, is pleased to appoint/promote Shri Naveen Jhalta, Inspector of Police (Seniority No. 70) to the Himachal Pradesh Police Services (Class-I Gazetted) in the pay scale of ₹15600-39100+5400 Grade Pay P.M. (PB:4), on regular basis, with effect from 1<sup>st</sup> June, 2021 or from the date of taking over as such, whichever is later.
