## **NOTIFICATION**

The production, consumption and trade in illicit Narcotic Drugs and Psychotropic Substances is a cause of concern for the Society and the enforcement authorities. In order to check and discourage such illegal activities, it has been decided to be constitute District Level Anti Narcotics Task force for the districts of Kullu, Kinnaur, Kangra, Shimla, Sirmour, Mandi and Chamba as under:-

The Deputy Commissioners may co-opt any other person in the

District Task Force as may be required.

The District Level Anti Narcotics Task force will meet as often as required and will:-

- i. Identify the areas of cultivation in the respective districts.
- ii. Create and activate anti narcotics cells in the districts and coordinate manpower requirement and equipment for these cells for anti narcotics work.
- iii. Take steps for destruction of the cannabis growth and arrest of the persons involved in cannabis extraction and trafficking.
- iv. Prepare cases for deportation of undesirable foreigners involved in trafficking.

- v. Identify trafficking routes/modus operandi of illegal drugs trafficking and launch counter operations.
- vi. Prepare development plans in specific identified areas, and
- vii Spread awareness among school children, college students and general public involving NGOs, on the harmful effects of drugs.
