**NOTIFICATION**

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor, Himachal Pradesh, is pleased to make the following rules further to amend the Himachal Pradesh Police Service Rules, 1973, namely:-

- Short title and commencement. 1. (1) These rules may be called the Himachal Pradesh Police Service (24<sup>th</sup> Amendment) Rules, 2022.  
(2) These rules shall come into force from the date of their publication in Rajpatra (e-Gazette) Himachal Pradesh.
