The Governor, Himachal Pradesh is pleased to order the creation of Sub-Divisional Police Offices at Jawalamukhi, district Kangra and Padhar, district Mandi with their headquarters at Jawalamukhi and Padhar alongwith the creation of following posts in the pay scales for the post of Dy. S.P ₹ 15600-39100+ ₹ 5400 GP, Head Constable ₹ 10300-34800 + ₹ 3600 GP, Constable (a) ₹ 5910-20200 + ₹ 1900 GP (b) ₹ 10300-34800 + ₹ 3200 GP (after 8 years of regular service) and Steno Typist (a) ₹ 5910-20200 + ₹ 2000 GP (b) ₹ 10300-34800 + ₹ 3200 GP (after 2 years of regular service) :-

In addition, the job of Sweeper will be outsourced in each above office. The Sub-Divisional Police Officer Jawalamukhi, district Kangra will supervise the work of Police Stations Jawalamukhi and Police Station Khundian alongwith works of Police Posts falling under aforesaid Police Stations whereas the works of Police Stations, Padhar and Jogindernagar alongwith police Posts falling under their control will be supervised by Sub-Divisional Police Officer, Padhar, district Mandi. The above approval will be subject to the condition to observe all the codal formalities procedurally in advance in this regard.
