NOTIFICATION

The Governor, Himachal Pradesh, in exercise of powers vested in him under Rule-15 of H.P. Police Services Rules, 1973 and in consultation with H.P. Public Service Commission, is pleased to appoint Ms Sushma Devi, D/O Shri Bhopal Singh, V.P.O. Gadheri, Tehsil Sunni, District Shimla, H.P. Wicketkeeper Batswoman of Indian Women Cricket Team to H.P. Police Services(Class-I Gazetted) in the pay scale of Rs.15600-39100+Rs.5400(GP) , as a special case, against 3% reservation to the distinguished sportspersons in direct recruitment in relaxation of the provisions contained in instructions issued by the Department of Personnel vide letter No.2-11/72-DP(A-II) dated 28.05.1999 and Rule 6(1)(a) of H.P. Police Services Rules, 1973 as amended from time to time by invoking provisions of Rule 21.

Ms Sushma Devi shall remain on probation for two years from the date of her joining as such.

Ms Sushma Devi will furnish a written acceptance of appointment offered to her immediately on receipt of this appointment order, to the Pr. Secretary(Home)to the Govt. of H.P. failing which the offer of appointment will be treated as cancelled.

In case of acceptance of appointment, Ms Sushma Devi shall report to the Director General of Police, H.P.

This appointment order is subject to the provisions of H.P. Police Services, Rules, 1973, as amended from time to time.

The offer of appointment is subject to the verification of character and antecedents of Ms Sushma Devi and if anything is found unsatisfactory in the report of verification, in that case the service of the candidate will be liable to be terminated immediately.
