TERMS AND CONDITIONS FOR AUCTION OF CONDEMNED VEHICLE:-

 The Vigilance Department, HP Secretariat, Shimla-2 is proposing to dispose off condemned Govt. vehicle on "as is where is basis" through sealed bids. The detail of the said vehicle is as under:-

- 2. Accordingly, sealed quotations are invited for the disposal of the said vehicle on the terms and conditions mentioned below. Persons, firms interested in purchasing the above mentioned vehicle may submit their highest value quotations in the enclosed Proforma in sealed cover addressed to the undersigned, latest by 1:00 P.M. till 10.12.2020 at the office of undersigned. The bidder or his/her representative, not more than one for each quotation, may be present, if they so desired, at the time of opening of Quotations which is scheduled for 3:00 P.M. on 10.12.2020 at Office of the undersigned.
- Interested Parties may submit their highest prices for the condemned vehicle as mentioned in tender notice in sealed covers latest by 1.00 PM till 10-12-2020. The inner cover containing quotations should be sealed properly. Sealed quotations may be submitted by hand or by post to the Director of Vigilance, H.P. Shimla in the Room No. G-19 (Ellerslie Building), H.P. Secretariat, Shimla-2. Both the inner and outer covers should be superscripted in bold letters "Quotations for vehicle No. HP 07B 0599".
- The disposal of this condemned vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Department. The auction process will be conducted by the authorized Committee. The vehicle can be inspected by the interested bidders physically between 11-11-2020 to 10-12-2020 upto 1:00 PM at H.P. Sectt. Premises Shimla-2 on any working day in office hours.
- The quotation should be accompanied by Earnest money of Rs. 5000/- in the form of Demand Draft in favour of the Director of Vigilance, Himachal Pradesh, Shimla 171002.

The analysis and evaluation of the bids received would be conducted on 10-12-2020 at 3:00 PM and selection of highest responsive bidder would be made and accepted subject to fulfillment of reserve price in sealed cover fixed by the condemnation board. The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE NO. HP 07B 0599".

- 6. The bidders are required to reveal their full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number etc.
- 7. The bids of the highest responsive bidder shall be accepted subject to fulfillment of reserve price in sealed cover fixed by the condemnation board and if the price offered by that bidder is not acceptable, negotiation will be held with the highest bidder. In case, such negotiation does not provide the desired result, the acceptable price will be counter-offered to the next highest responsive bidder(s).
- 8. In case of tie of the highest bid subject to fulfillment of reserve price in sealed cover fixed by condemnation board, negotiation will be held with the concerned bidders for obtaining single higher rate.
- 9. If the highest bidder/successful bidder fail to deposit the sale price within 03 working days time, his entry fee/bid security deposited by him shall stand forfeited. In case the offer is withdrawn by any bidder, the earnest money deposited (EMD) by him shall also be forfeited. No representation in this regard shall be entertained by this Department.
- 10. The successful bidder will be required to deposit the bid amount by means of Demand Draft in favour of the Director of Vigilance, H.P. Shimla -2 within three working days after award of bid. However, bid security of the successful bidder (s) will be adjusted in sale amount. The bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable. Thereafter, sale release order will be issued to the selected bidder and sold vehicle will be handed over to the selected bidder only after receiving the balance amount and documentary evidence in support of residential status (Ration Card/Voter Identity Card/Aadhar Card/Parking space in case of individual and Registration Certificate in case of firms etc.)
- 11. The sold vehicle will be lifted by the successful bidder (s) within 3 days of depositing the money at their own expenses. No assistance/ transportation will be provided by the Vigilance Department. Permission to take out disposed vehicles from the aforesaid premises will not be allowed on public

holiday and Sunday. After receiving the vehicle, the selected bidder would be solely responsible for any incident.

- 12. The highest bidder/the bidder who has been awarded the bid shall have to apply for change of ownership of this vehicle and get ownership within one month and will also be responsible for getting the ownership of the Vehicle(s) transferred in the name of respective bidder at his own cost expeditiously.
- 13. Bid security of unsuccessful bidders shall be returned after finalizing the bidding process of the vehicle to the party.
- 14. Disputes, if any, shall be subject to jurisdiction in the Court of Shimla only.
- 15. If the highest acceptable quoting party fails to honour the bid, his bid will be cancelled & its Entry fee/bid security forfeited. In such an event, an opportunity shall be given to the next highest quoting acceptable bidder (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1party. In case of any dispute, decision of the Director, Vigilance HP shall be final.
