#### NOTIFICATION

- 1) These Rules may be called the Himachal Pradesh Home Guards, Civil Defence and Fire Services Department, Civil Detence Instructor/Chief Instructor/ Platoon Commander/ Administrative Officer / Assistant. Store Officer. Class-III. Gazetted) Recruitment and Promotion Rules, 2010.
- 2) These Rules shall come into force from the date of publication in Raiptra. Himachal Pradesh.

In all cases of promotion, the continuous adhoc service rendered in the feeder post if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these Rules for promotion subject to the conditions that the adhoc appointment/promotion in the feeder category had been made after following proper acceptable process of selection in accordance with the provisions of R & P Rules

In all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including the service rendered on adhoc basis followed by regular service/ appointment) in the feeder post in view of the provisions referred to above, all persons senior to in the respective category/post/cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration.

Provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of at least three years or that prescribed in the Recruitment & Promotion Rules for the post, whichever is less.

Provided further that where a person becomes ineligible to be considered for promotion on account of the requirements of the proceding provisio, the persons(s) junior to him shall also be deemed to be ineligible for consideration for such promotion.

Explanation: - The last proviso shall not render innior incumbents incligible consideration for promotion if the senior ineligible persons happened to be ex-serviceman recruited under the provisions of Rule-3 of Demobilized Armed Forces Personnel Reservation of Services in Himachal State Non-Technical Services) Rules, 1972 and having been given the benefit of seniority thereunder or recruited under the previsions of Rules-3 of Ex-Servicemen (Reservation of vacancies in the Himachal Pradesh Technical Service) Rules. 1985 and having been given the benefit of seniority there under.

The Commandant General Home Guard/Civil Defence H.P. after obtaining the approval of the Government to fill up the vacant posts on contract basis will place the requisition with the concerned recruiting agency i.e. H.P. Subordinate Services selection Board, Hansirpur.

(c) The selection will be made in accordance with the eligibility conditions prescribed in these Rules

### II)CONTRACTUAL EMOLUMENTS:

Civil Defence Instructor/Chief Instructor/platoon Commander / Administrative officer/ Assistant Store officer appointed on contract basis will be paid consolidated fixed contractual amount @ Rs. 13,900/- P.M. (which shall be equal to minimum of the pay band +grade pay). An amount of @Rs 420/-( @3 % of the minimum of pay band +grade pay of the post) as annual increase in contractual emoluments for the subsequent years will be allowed if contract is extended beyond one year.

# (III)APPOINTING/DISCIPLINARY

AUTHORITY:

The Commandant General Home Guards/Civil Defence, H.P. will be appointing and disciplinary authority.

# (IV) SELECTION PROCESS:

Selection for appointment to the post in the case of Contract Appointment will be

(which shall be equal to minimum of the pay band +grade pay An amount of Rs 420 (3% of the minimum of pay band + grade pay of the post) for further extended years and no other allied benefits such as senior/selection scales etc, will be given.

(b) The service of the contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance conduct of the contract appointee is not found satisfactory.

(c) Contract appointee will be entitled for one day casual leave after putting one month service. This leave can be accumulated up to one year. No leave of any other kind is admissible to the contract appointee. He/She shall not be entitled for Medical Reimbursement and LTC etc. only maternity leave will be given as per rules.

- 3. The service of "FIRST PARTY" will be purely on temporary basis. The appointment is liable to be terminated in case the performance/ conduct of the contract appointee is not found good or if a regular incumbent is appointed/ posted against the vacancy for which the first party was engaged on contract.
- 4. Contractual Civil Defence Instructor/Chief Instructor/platoon Commander/Administrative officer Assistant Store officer will be entitled for one day casual leave after purting in one month service. This leave can be accumulated upto one year. No leave of any kind is admissible to the contractual Civil Defence Instructor/Chief Instructor/platoon Commander/Administrative officer/ Assistant Store officer. He will not be entitled for Medical Reimbursement and LTC etc. Only maternity leave will be given as per Rules.
  - 5. Unauthorized absence from the duty without the approval of the controlling Officer shall automatically lead to the termination of the contract. A contractual Civil Defence Instructor/Chief Instructor/plateon Commander/Administrative officer/ Assistant Store officer will not be entitle for contractual amount for the period of absence from duty.
  - 6. An official appointed on compact basis who have completed five years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.
  - 7. Selected candidate will have to submit a certificate of his/her firmess from a Government/ Registered Medical Practitioner. In case of women candidates pregnant beyond twelve weeks will render of temporary unfit till the confinement is over. The women candidate should have reexamined for fitness from an authorized Medical Officer Practitioner.



- 8. Contract appointee shall be entitled to TADA if required to go on tour in connection with his/her official duties as the same rate as applicable to regular counter-part official at the minimum of pay scale.
- The Employees Group Insurance Scheme as well as EPF GPF will not be applicable to contractual appointee(s).
