- ii) Purchase of vehicles/furniture etc. must be effected through GeM and if the proposed vehicles are not available on Gem then through authorized dealer(s) only.
- iii) Completion of all codal formalities procedurally in advance in this regard.

5. The expenditure on this account shall be debited under Head of Account 2070-Other Administrative Services, 108-Fire Protection and Control, 02-District Staff (SOON) Sub Head 01-Salaries and Sub Head 27-Motor Vehicle.


