I am directed to refer to the subject cited above and to convey the approval of the Government for implementing the judgment dated 11-3-2015 delivered by the Hon'ble Supreme Court of India.

In this regard it is stated that the remuneration to be paid w.e.f.1-7-2016 to the Home Guard volunteers in compliance to the directions of the Hon'ble Supreme shall be determined and calculated in the following manner:-

Basic Pay + Grade Pay+ D.A.(Existing) + Washing Allowance(Per day)

(i). Minimum of Pay (Pay Scale Rs. 5910-20200 )	= Rs. 5910/-
(ii) Grade Pay	=Rs. 1900/-
(iii) DA @119%	=Rs. 9294/-
(iv) Washing Allowance @ Rs. 1/per day	= Rs. 30/-

Total: = Rs. 17134/- (i.e. Rs. 571/- per day).


Further, the arrears on this account will be released in favour of Home Guard volunteers w.e.f. 14-10-2015 the date on which the review
