- iii) Surplus vehicles, if any, over & above the approved fleet strength may either be condemned strictly as per policy of the Government or surrendered to the GAD-Pool for its further deployment to the needy Departments;

- iv) Completion of all codal formalities procedurally in advance in this regard.
